



Agenda Item 8: Status of contributions to the convention

Purpose

1. To table the report on the status of party contributions to the Waigani Convention up to 16 August 2017.

Background

- 2. Rule 6.1(a) of the Financial Rules for the Waigani Convention on Contributions highlights that the contributions made each biennium by Parties is based on a scale adopted by consensus of the Parties. Such contributions shall be due on the first day of the relevant biennium.
- 3. Furthermore, Rule 6.3 require that the Director General of SPREP shall acknowledge promptly the receipt of all pledges and contributions and shall inform the Parties, every year, of the status of pledges and payments of contributions.
- 4. Pursuant to Rule 6.3, presented here is the status of pledges and payments of contributions received as at 16 August 2017.

 - encourage the parties with outstanding contributions to work with the Secretariat on ways to make payment of these contributions
