#### Introduction

This report covers Environment Impact Assessment (EIA) training and an introduction to State of Environment (SoE) reporting and National Environmental Strategy (NEMS) development, delivered for the Government of Niue, 15<sup>th</sup>-18<sup>th</sup> August, in Alofi.

The workshop was facilitated by Mr Jope Davetanivalu, Planning and Capacity Development Adviser (PCDA), and Ms Melanie Bradley, Environmental Planning Officer (EPO), from SPREP's Environmental Monitoring and Governance (EMG) Division.

The opening address was delivered by Dr Josie Tamate (Mrs), Director General, Ministry of Natural Resources. Dr Tamate warmly welcomed the EIA training and the skills development opportunity for government officials, given Niue is soon to enact its EIA Regulations.

Mr Sauni Tongatule, Director, Department of Environment, emphasised the importance of the EIA workshop for Niue and the need to develop internal EIA guidelines to support effective implementation of Niue's new EIA Regulations.

The workshop was attended by representatives from the Department of Environment; Department of Transport; Department of Justice, Lands Survey and Communication Services; Tāoga Niue; Project Management and Coordination Unit; and Niue Meteorological Service. A total of fifteen government officials attended the workshop across the four day programme (refer to Appendix 1, Workshop attendance sheets).

#### Background and justification

In 2015 a revised *Environment Act* was enacted in Niue. To complement this Act, Environment (Development Consent and Environmental Impact Assessment) Regulations have been drafted and are being considered by Cabinet.

In light of these legislative developments and potential renewable energy developments, a need for EIA training was identified by Mr Andrew Irvin from the Sustainable Energy Programme at IUCN, in consultation with Mr Sauni Tongatule, Director of the Department of Environment, Niue. IUCN sent a request to the EMG A/Director, Mr Clark Peteru, seeking assistance with the delivery of EIA training.

In consultation with IUCN and the Department of Environment, EMG's PCDA and EPO developed a four day workshop programme. In addition to EIA, the programme covered SoE reporting and NEMS development, to progress other core areas of EMG work.

#### **Objectives**

- 1. Provide participants with an overview of SPREP and its capacity-building work related to environmental policy, planning and assessment;
- 2. Develop participants' understanding of the environmental impact assessment (EIA) process and how it can be effectively applied in Niue;
- 3. Strengthen participants' EIA skills through practical exercises and discussion; and

4. Provide an introduction to SoE reporting and the development of a NEMS for Niue, and determine the interest of government in progressing SoE and NEMS in 2017.

#### Workshop programme

Refer to Appendix 2 for a detailed workshop programme.

#### **Outcomes**

At the beginning of the workshop it was determined that government officials in Niue have limited knowledge of and experience with EIA. However, by the end of the workshop participants' knowledge of the EIA process had greatly improved. This was evident in the way the officials participated in practical exercises and also in the responses they provided on workshop evaluation forms.

Evaluation forms were completed by eight participants on the final day of the workshop. Key findings:

- 1. Seven participants 'strongly agreed' and one participant 'agreed' that the workshop had helped to develop their knowledge and understanding of EIA.
- 2. All participants 'agreed' they will be able to more effectively implement or participate in the EIA process.
- 3. All participants 'strongly agreed' that the workshop content was easy to follow, the trainers were well prepared, and the trainers effectively presented the material.
- 4. Six participants rated the workshop overall as 'excellent' and two rated it as 'very good'.
- 5. Some participants expressed a desire to undertake more practical exercises, especially exercises focusing on proposed developments in Niue.

Aside from the presentations and exercises that were delivered and facilitated by SPREP, there were two presentations delivered on behalf of partner organisations. Ms Jazinta Levi, from the Government of Niue's Project Management and Coordination Unit, delivered a presentation on the IUCN and UNEP Low Carbon Islands Project, which included discussion points related to environmental and social impact assessment and strategic environmental assessment. A representative from the Ministry of Natural Resources and Environment, Government of Samoa, delivered a presentation on the development of 3D models to support resource management and land-use planning. A 3D model will be constructed to support development planning in Alofi, which will help to ensure EIA is applied within a strategic planning context.

Representatives from various government departments expressed a strong interest in progressing an SoE report and NEMS for Niue, following the introductory SoE and NEMS presentations delivered by SPREP's PCDA.

#### Follow-up actions

#### **Department of Environment**

- It is recommended the Department of Environment undertake eight steps to help establish an effective EIA process in Niue:
  - 1. Consult widely on the draft Environment (Development Consent and Environmental Impact Assessment) Regulations, to ensure the Regulations take into account all

relevant government policies and laws, and to secure inter-agency support for EIA implementation.

- 2. Review and revise the draft EIA Regulations taking into account the following:
  - the Department of Environment must only act as an independent administrator of the EIA process and not be involved with conducting on-ground impact assessments and writing EIA reports; and
  - direct reference should be made to relevant government policies and laws, especially if requested by stakeholders.
- 3. Ensure the scoping step of the EIA process is undertaken for all development consent applications, which will result in the development of terms of reference to guide onground impact assessments and the preparation of EIA reports.
- 4. Give consideration to the establishment of a trust account under the *Environment Act*, to be administered by the Department of Environment and to allow for the collection of fees related to environmental laws and programmes and the dumping of rubbish at landfill sites. Funds from the trust account could be used to support the operations of the Department e.g. EIA monitoring and enforcement, EIA awareness-raising.
- 5. Undertake a national EIA awareness-raising program that targets stakeholder groups internal and external to government.
- 6. Develop internal guidelines/standard operating procedures for EIA, with reference to the checklists and templates in SPREP's Regional EIA Guidelines.
- 7. Appoint enforcement officers, as required under the *Environment Act*.
- 8. Undertake strategic land-use planning, land-use zoning and business licensing, to provide a supporting framework for EIA.
- It is recommended that Mr Sauni Tongatule, Director of the Department of Environment, write
  to the A/Director of EMG, Mr Clark Peteru, requesting assistance with the development of
  Niue's SoE report and NEMS in 2017. Mr Tongatule is to raise this request with Mr Peteru
  during the 27<sup>th</sup> SPREP Meeting in Niue.

#### SPREP

- SPREP's EMG division is ready to:
  - 1. Provide technical assistance and support with EIA implementation, SoE reporting and NEMS development, as required.
  - 2. Support the Government of Niue and IUCN with applying the EIA process to potential renewable energy developments in Niue.
