Two consecutive meetings will be hosted at the SPREP campus in Apia, Samoa for the:

- Pacific Regional Preparatory Meeting for the 14th Conference of the Parties (CoP) to the CBD, and
- CBD-6th National Report Technical Support Regional Workshop.

These meetings will be held at the SPREP campus in Apia, Samoa. It is anticipated that the country representative for both of these meetings, will in most cases be the same participant.

#### CBD Pre-COP Meeting, 24-26 September

In preparation for the 14thCBD CoP, the Secretariat will be conducting a preparatory meeting for the Pacific islands region over three days from the 24<sup>th</sup> to 26<sup>th</sup> September 2018.

The main objective of the Preparatory meeting is to provide a forum for the region in particular those countries that are parties to the CBD to come together and discuss key regional priority issues and prepare regional positions, as appropriate. A key part of the preparatory meeting is to strengthen engagement at COP meeting and continue with the One Pacific Voice which has been a very effective approach adopted by Pacific island countries at past COP meetings.

<u>CBD 6<sup>th</sup> National Report Technical Support Regional Workshop, 27-28 September 2018.</u>
As part of the technical support project for the Sixth National Reports (6NR) to the CBD, UN Environment and UNDP are holding a regional workshop to assess the status of the reports preparation and to offer technical assistance where needed.

The main objectives of the technical support workshop are:

- Hold a collective discussion on the status of the project implementation, exchange views and share experiences:
- Clarify possible doubts concerning the formats, information sources and tools available:
- Hold one-to-one or small groups sessions to go through the work done so far on the online reporting tool.
