The Environment Institute of Australia and New Zealand (EIANZ), a partner of SPREP, is hosting its 2024 Annual Conference themed "Moving beyond transition", scheduled to take place in Sydney, Australia, from 6th to 8th November 2024.

The EIANZ Annual Conference stands as a premier forum for environmental practitioners and experts across Oceania. It provides an unparalleled opportunity for knowledge exchange, experience sharing, and discourse on critical environmental challenges and their potential solutions. This year's conference will focus on charting the course for our rapidly evolving profession, with particular emphasis on developing multidisciplinary approaches to complex environmental issues.

SPREP will provide financial support for one (1) participant per country, covering travel costs and a daily subsistence allowance (DSA). All travel arrangements will adhere to the SPREP Travel Policy.



Please be advised that visa arrangements, accommodation bookings, and travel insurance procurement remain the responsibility of the traveller. Upon request, SPREP can furnish a letter from the conference organizers to facilitate visa applications.
