- 3. STAC 10 of the Waigani Convention: Scheduled for 13-14 March 2025.

However, if they have different focal points, both can be nominated. Also, since this Basel/Waigani meeting is a preparatory meeting for the BRS Convention meeting in Geneva in April/May 2025, we request that the nominee for these meetings be the same person attending the Geneva meeting.

All sponsored travel arrangements will adhere strictly to the SPREP travel policy, inclusive of economy return airfare via the most direct and economical route. Please note that the responsibility for travel insurance and visa expenses lies with the traveller.

We kindly request the completion and return of the attached nomination form (refer to annex 1) by Monday, 18 November 2024. This will confirm your attendance and enable the Secretariat to initiate travel preparations ahead of the Christmas holiday season.
